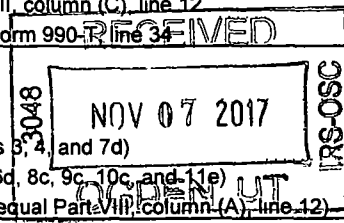

**Eagle Island, Inc. worked toward amending the Town of Santa Clara Land Use Code to allow Eagle Island to resume operation as a camp. Tentative approval for the land use amendment occurred in December 2016, pending an environmental impact study. The Town subsequently approved the land use amendment in January 2017. In 2016, the organization received donated legal services totaling \$111,478.**

**Eagle Island was opened for limited public access in 2016 which included three "Open Island" Days and several historic tours. Volunteers were also on the Island assisting in repair and maintenance projects.**
